### 6. Report of Officers: President, Vice President, Secretary, Treasurer, and Member at Large.

**President:** Director Neyman reported that he just signed the Planning Grant Application, requesting \$1.2 million. Director Schoenberg added, Self-Help Enterprises will be paying for a hydrology study. This will study the basin to see if providing water to Lake of the Woods will affect the aquifer in Frazier Park. It will also help identify the best location for test wells, and take water samples to find the areas with the highest water quality.

Vice-President: None.

Secretary: None.

**Treasurer:** Director Schoenberg reported she has not yet moved the \$50,000 back into the Operating Fund from when it was transferred to cover the USDA Loan Payment. Automatic transfers into the Reserve and Replacement Accounts on loans will also need to be set up.

The FPPUD website has been updated with the newest financials, and Minutes.

Member at Large: None.

#### 8. Manager's Report.

The crew accomplished 140 work orders. There were three after hours call outs. The new building for Well 6 has been completed. The crew changed out all of the office lighting to energy efficient LEDs, and will continue to replace lighting at a few additional sites. It was estimated that it would take 2 ½ years to recoup the cost of purchasing the LEDs, after which the District will begin to see the savings.

#### a. Discussion/Vote on Quote from Advanced Infrastructure Technologies.

There have been several recent instances where the District needed to locate pipes, valves, and meters. The current locating equipment has not been functioning properly to get this work accomplished. General Manager Allison expressed that the FPPUD cannot function properly without it. The cost for a line locator and metal detector came out to about \$8,900. This cost can come out of the Pipeline/System Reserve Fund.

It requires all elected officials take Sexual Harassment Training every two years. The law offices of Young Wooldridge would be willing to come to Frazier Park, and do the training for the Board, for a flat cost of \$500. Bill Hopper added that Lebec Water Board was able to take the training online at a cost of \$20 per member. Tiffany will look into an online training, and add it to the Agenda for the Regular Meeting in January.
