a. Public Concern: Susanne Green

The FPPUD received an email from Susanne Green in which she expressed concerns that increased well drilling could lead to seismic activity. She suggested treating surface water as an alternative to further well drilling. The Board read her letter out loud. In order to address her concerns, GM Allison explained that treating surface water is monumentally cost prohibitive. He also researched to see if drilling for water has been linked to seismic activity and found only a link between fracking and increased earthquake activity. Ms. Green's concerns were also sent to hydrogeologist Dr. Ken Schmidt. He responded with a letter that concluded, "There is no evidence that pumping groundwater in the Frazier Park area would create 'man-made changes in our local geology'".

The bid went out for the equipping of the new well and is due back tomorrow. After the bids come back the FPPUD can move forward with picking the contractors.
