IN THE MATTER OF:

**WATER AVAILABILITY OR STANDBY CHARGES ASSESSMENT; DELINQUENT
ACCOUNTS ASSESSMENT; RESOLUTION AUTHORIZING KERN COUNTY TO ACT
AS FPPUD'S AGENT IN THE COLLECTION OF ASSESSMENT TAXES FOR THE
2024 - 2025 TAX YEAR.**

WHEREAS, the Board of Directors of the Frazier Park Public Utility District pursuant to Section 16475 of the Public Utilities Code of the State of California established a water availability assessment or standby charges on boundaries served by the Frazier Park Public Utility District for an amount of five dollars (\$5.00) for each parcel.

WHEREAS, none of the said standby or water availability charges have been paid; and

WHEREAS, said payments may be placed on the tax roll pursuant to Articles 3 and 8, Chapter 4, Division 7 of the Public Utilities Code of the State of California; and

WHEREAS, the Board of Directors of the District pursuant to Section 16469 of the Public Utilities Code of the State of California has provided that all charges for commodities or services furnished and delinquent by more than six months as of June 1, 2024 described in Exhibit A, attached hereto shall be added to and become a part of the annual assessment levied upon that parcel upon which the commodity or service was used; and

WHEREAS, the amounts to be assessed and levied against the same for delinquent accounts for the rendering of commodities and the services by the District; and

WHEREAS, said delinquent accounts may be placed on the tax roll pursuant to Articles 3 and 8, Chapter 4, Division 7 of the Public Utilities Code of the State of California.

NOW, THEREFORE, BE IT RESOLVED:

Pursuant to the provisions of Section 16475 and Articles 3 and 8, Chapter 4, Division 7 of the Public Utilities code for the State of California that the unpaid water availability or standby charges incorporated by reference be added to the assessments on the land to be collected with the District utilizing the services of the County of Kern for collection of its taxes and assessments. That the Auditor-Controller of Kern County charges are to be added to these figures; and

FURTHER RESOLVED:

To the extent required by law, the rate charge fee or assessment requested by the Frazier Park Public Utility District to be placed on the 2024-2025 County Tax Roll does comply with the applicable provisions of Article XIII D of the California Constitution, therefore, Proposition 218 compliant.
